### Part A: Pupil premium strategy plan

#### Statement of intent

At Burnside Primary School, we believe that all children have the right to reach their potential and we strive to remove barriers to enable this to be possible. Pupil Premium expenditure is planned and targeted to ensure that resources are allocated to maximise opportunities for identified pupils linked to the desired outcomes.

### Our ultimate objectives are:

- ✓ To narrow the attainment gap between disadvantaged and non-disadvantaged pupils.
- ✓ For all disadvantaged pupils in school to make or exceed nationally expected progress rates.
- ✓ To support our children's health and wellbeing to enable them to access learning at an appropriate level.

### We aim to do this by:

- ✓ Ensuring that teaching and learning opportunities meet the needs of all the pupils
- ✓ Ensuring that appropriate provision is made for pupils who belong to vulnerable groups, this includes ensuring that the needs of socially disadvantaged pupils are adequately assessed and addressed
- ✓ Recognising that not all pupils who receive free school meals will be socially disadvantaged
- ✓ Understanding that not all pupils who are socially disadvantaged are registered or qualify for free school meals. We reserve the right to allocate the Pupil Premium funding to support any pupil or groups of pupils the school has legitimately identified as being socially disadvantaged.
- ✓ Pupil premium funding will be allocated following a needs analysis which will identify priority classes, groups or individuals. Limited funding and resources means that not all children receiving free school meals will be in receipt of pupil premium interventions at one time.

## **Challenges**

This details the key challenges to achievement that we have identified among our disadvantaged pupils.

Challenge number	Detail of challenge
1	A number of children who are eligible for Pupil Premium do not enter Early Years at age related expectations
2	For a number of children eligible for Pupil Premium, emotional resilience is lower than that of their peers. This can affect their concentration, especially when working with others or when tasks are challenging
3	The children need to experience high quality teaching and feedback to ensure that they make progress and develop skills and knowledge
4	The disadvantaged gap in RWM has widened as a result of the pandemic and subsequent periods of enforced school closure
5	Attendance percentages are low and the number of persistent absentees has increased

## Part C: Governance – monitoring the effectiveness of the Pupil Premium Strategy

Governors are involved in evaluating our Pupil Premium Strategy termly. Please see below a brief summary of discussions about the effectiveness of the strategy to address the intended outcomes.

Activity	Autumn 2024 Evaluation	Committee Date
Teaching Priorities	Miss Pattison has provided SPAG training for all teachers. This was successful in supporting teachers in their understanding of the SPAG curriculum as well as signposting them to resources available to enhance teaching and learning. The new curriculum for the teaching of spelling, punctuation and grammar has been implemented so that children know more and remember more. Impact is being measured through the introduction of monitoring SPAG scores as part of our summative assessment data input. Interventions in order to ensure that children acquire basic skills are carefully planned by individual class teachers. This includes the continuation of our pre-learning.  Miss Pattison and Mrs Renwick have attended training in order to ensure that they are equipped to evaluate the impact of our curriculum. This training will be disseminated and utilised from the Spring term.	
Targeted Academic Support	Pre-learning and interventions were carefully planned for the Autumn term to meet the needs of pupil premium children. Teaching assistant and teacher time is carefully planned to ensure that children are provided with a varied diet of expertise from all adults.  Lists for 1:1 and small group reading for lowest 20% have been established and this takes place regularly. Progress is primarily	

	monitored by the class teacher and reading lead – Mrs Pattison.  A Nurture Hub has been established in our Outdoor Classroom. It is accessed by eight KS2 children and eight KS1 children. The children attend for two sessions per week and are facilitated by trained members of staff. Progress is monitored using the Boxall profile. It will be reported upon when the assessment cycle is completed in Spring term.	
Wider Strategies	The PP funding continues to support the facilitation of After School Clubs by school staff and outside agencies in order to continue to provide them free of charge. In the Autumn term, 21% of pupils accessed an After School Club. 45% of these are Pupil Premium children. We aim to increase this percentage through incentives in the Spring and Summer term.  We planned to use PP funding to subsidise the residential in Y5 and Y6; however, due to low uptake for the Y5 residential, it was necessary to combine the trips. We were able to subsidise more than anticipated as a result. Staff have established Attendance TAF meetings for identified families. Overall percentages as well as unauthorised absence data will be monitored closely and reported upon later in the term.  PP funding is also used in the development of the cultural capital of children. So far this year it has helped to fund three of the year group trips from the Experiences Passport: A Christmas Carol at The Tyne Theatre, a cinema trip to see Mario and a soft play experience for our youngest learners. Whilst there is no numerical impact data for this, pupil voice tells us that the introduction of these trips have had a positive impact upon the cultural capital of our children.

Teaching Priorities	This term, there has been a significant increase in focus upon ensuring the acquisition of basic skills through timetabling, targeted teaching and carefully planned interventions from individual starting points. By focusing upon the basic skills and	

	prioritising these, it is hoped that children make faster progress over all.  Senior leaders attended training in order to ensure that they are equipped to evaluate the impact of our curriculum and are not implementing this training in order to carry out a full curriculum review. The review will be concluded at the end of the Summer term. A further course is being facilitated by DCC in order to further build evaluation skills for leaders in terms of the Early Years. This will be attended by the HT and EY lead in the Summer term.	
Targeted Academic Support	Again, pre-learning and interventions were carefully planned for the Spring term to meet the needs of pupil premium children. Teaching assistant and teacher time is carefully planned to ensure that children are provided with a varied diet of expertise from all adults. A new timetable ensures that interventions are happening consistently and baseline and end point data supports staff in measuring small steps of progress.  Lists for 1:1 and small group reading for lowest 20% have been updated and this takes place regularly. Progress is primarily monitored by the class teacher and reading lead – Mrs Pattison.  Our Nurture Hub (The Den) has been established in our Outdoor Classroom and in place since October half term. It is accessed by eight KS2 children and eight KS1 children. The children have now increased sessions to three times per week and are facilitated by trained members of staff. Progress is monitored using the Boxall profile. There were only two children who did not make progress from their start points; however, these children have been discussed at Pupil Inclusion Panel and have been categorised as no longer meeting the criteria for nurture at this point.	
Wider Strategies	The PP funding continues to support the facilitation of After School Clubs by school staff and outside agencies in order to continue to provide them free of charge. In the Autumn term, 21% of pupils accessed an After School Club. 45% of these are Pupil Premium children. We aim to increase this percentage through incentives in the Spring and Summer term.	

The Y5/6 Residential was hugely successful again this year with pupil voice being the main measure of the level of this.  Staff continue to facilitate Attendance TAF meetings for identified families; however, some families have since been referred to the Local Authority and have been served with a notice to improve. Overall percentages, as well as unauthorised absence data, will continue to be monitored closely and reported upon later in the term.  PP funding also continues to be used to enhance cultural capital through supporting trips for our children.
